#### **REGISTRATION FEE**

• This fee is **required** with every student application. Payment covers application processing and temporarily reserves a classroom space until the Admissions Committee grants final acceptance.

Early Bird Registration (before June 15) -- \$35 per student

After June 15 -- \$100 per student

### **TUITION DEPOSIT 2020-2021**

- Payment of this \$250 deposit reserves the student's enrollment for the upcoming school year.
- CCS does not grant full acceptance to any student until the tuition deposit is paid.

**After school care ends at 5:00 p.m.** Families whose students are not picked up by 5:00 p.m. will be charged a \$10 late pick-up fee AND an additional \$1 for each additional minute thereafter. School care is not available when school is not in session.

# **General Information**

#### **Payments**

Student tuition is billed to parents in ten statements. Statements are emailed around the 20th and payments are **DUE ON THE FIFTH (5<sup>th</sup>).** The tuition deposit is billed at the end of May and due by June 15. The first of ten tuition payments is due August 5, and the last tuition payment is due May 5.

#### **Late Fee**

CCS adds a \$25 late fee for payments received after the fifteenth (15<sup>th</sup>) of the month and a \$100 late fee for accounts thirty days past due. Please call the Finance Office if your payment will be late.

#### **Lunch Accounts**

With parental permission, students may order lunches in homeroom. Full details of these purchases are included on the monthly bill. The lunch price for Pre-Kindergarten students is \$3.50 per day. Beverages (white milk, chocolate milk, juice, water) in addition to or separate from lunch trays are \$0.50 each.

#### Withdrawal

In the event a student is withdrawn from CCS, all fees are non-refundable and non-transferable. The parent/guardian is responsible to pay the final prorated monthly tuition payment based upon the actual number of days the student is still enrolled. No student is officially withdrawn until withdrawal papers are signed by both the parent/guardian and the Administrator in a joint meeting.

## **Registration Policy**

Registration is open to all students who meet the age-appropriate cutoff date of August 1. Parents must agree to abide by Pre-Kindergarten policies and philosophy. By its right as a private institution, Colonial Pre-Kindergarten reserves the right of setting and maintaining its own standards for student conduct, dress, and philosophy presented at school.

- 4. Birth certificate on file
- 5. Affirmation by the parent that the student able to use the restroom without assistance
